Abstract:




Fig. 1. The combination of physical education and national tradition in universities of Chongqing

DISCUSSION

In the teaching organization activities, teachers should mainly implement the education idea of health first, weaken the competitiveness of sports, emphasize more on the fitness of sports, increase the sports necessary to contact with social life and explain the scientific training methods in the process. Break the viewpoint of subject centered theory, guide ecological education to physical education, let students learn the basic knowledge of ecology, basic science, let students realize the relationship of interdependence, mutual restriction and interaction between human society and natural ecological environment. Better cultivate students' awareness of ecological sports.

ECOLOGICAL TEACHING CONTENT

The so-called ecological teaching content, the most simple and straightforward is to require physical education teachers to combine with the surrounding natural environment in teaching, make full use of the surrounding geographical environment, develop appropriate teaching content, to achieve the purpose of teaching and complete the teaching task. In the process of teaching, teachers can use the surrounding environment to organize students to go out for outings, kite flying, jogging and other activities in spring and autumn. In this way, they can exercise their bodies, breathe the fresh air of nature, and form the idea of loving nature. We can choose the teaching content according to the specific situation of the school. For example, Chongqing University, a city center university, is not easy to develop. In these circumstances, an artificial rock climbing hall has been built in the school. But only in the heart to comfort students, but in the combination with nature is relatively lacking. But Southwest University, Chongqing University of Arts and Sciences and other schools, located in the suburbs, have a good natural ecological environment. They can organize a large number of students to carry out orienteering, exercise their ability to use compass and other instruments, as well as the ability to coordinate between people.

THE ECOLOGICAL RELATIONSHIP BETWEEN TEACHERS AND STUDENTS IN TEACHING

In the ecological relationship between teachers and students, students are required to study independently, and teachers only play an auxiliary role in the teaching process. The development of ecological sports activities and human development are mutual influence, mutual dependence and common progress.

CONCLUSIONS
